All contest entries will be automatically opted into the "American Dairy Association Indiana Mailing List" and you will receive periodic marketing messages via email. Your information is being provided solely to American Dairy Association Indiana and not to Facebook. Contests are open to all persons who are aged 18 years or older.

The drawings will be conducted by American Dairy Association Indiana, and the results of the drawings are final. Winner(s) will receive various prizes as available.

Prize(s) will be mailed to winner. Not all entrants will be notified.

Employees, Executive Committee members and officers of American Dairy Association Indiana, and their immediate family members, households, or employees, or those who reside with such employees, Executive Committee members and officers, are not eligible to participate in or win the Contests.
